Please email the form on the same day as you make the payment.

If you or a member of your household living at the same address pay tax and you or the taxpayer sign and date the gift aid declaration, St Helens u3a can reclaim 25p tax on each £1 of your subscription. If you pay tax at the higher rate you can claim further tax relief in your Self-Assessment tax return.
